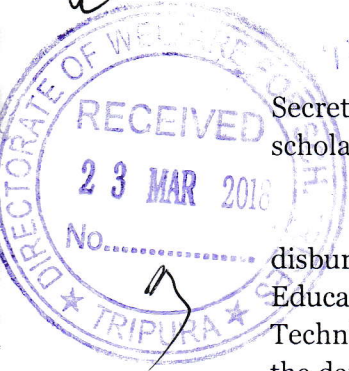

Minutes of the meeting held on 20th March to discuss on 2018 to discuss on Scholarships of Tribal Students



A meeting was held on 20th March at 11 AM in the chamber of Principal Secretary, Finance & IT to discuss on the issues pertaining to disbursement of scholarships to tribal students. The list of participants is given in Annexure-I.

At the outset, Secretary, Tribal Welfare informed that scholarships were being disbursed manually. It was informed by IT Directorate that Education (Higher) and Education (School) were using National Scholarship Portal for their scholarships. Technical Director, NIC intimated that same schools were entered more than once in the database created by Tribal Welfare Department for scholarship.

After detailed deliberation, the following decisions were taken: -

- a) NSP 2.0 developed by NIC should be adopted by all departments disbursing scholarship to students. **[Action: -Edu(School/Higher)/TW/SCW]**
- b) The Software is generic and meeting Departmental requirement of Registration (by Students), Verification/ Validation (by Schools, Inspectors etc. in different layers and required and configured by the scheme administering Department), and Approval (single or multilayered, configurable as per scheme requirement). Major schemes applicable in the state are all on-boarded and implemented in NSP2.0.
- c) A Nodal Officer/Department may be nominated for uniform administration of Educational Institutions and Schemes, rather than every scheme on-boarding department doing it separately and inconsistently. Department of Education (School/Higher) would nominate a nodal officer for overall administration of the Application and communicate the name to all stakeholders. **[Action:-Edu (School/Higher)]**
- d) NSP 2.0 and CTOS application need to be integrated to enable both way transfer i.e. data of approved applicants from NSP 2.0 to CTOS for disbursing payment and for providing payment feedback from CTOS to NSP 2.0 portal. NIC has assured to finish this integration within 15 days. **[Action: -NIC/Finance]**
