EXPRESSION OF INTEREST

Expression of Interest (EOI) is hereby invited from the reputed and recognized Nursing Institutions located outside Tripura for imparting quality education in B. Sc. Nursing / Diploma in General Nursing & Midwifery (GNM) to ST/SC/RM & OBC students. The students shall be sponsored by the Tribal Welfare / SC Welfare / Religious Minorities & OBC Welfare Department, Govt. of Tripura during the year 2017-18 (for B. Sc Nursing - tentative 95 seats and for GNM - tentative 330 seats).

The terms and conditions of the EOI are as follows:-

1. The Institute must have the approval of Indian Nursing Council and State Nursing Council from the concerned University, whichever is applicable and up to date registration certificate of INC and SNC of 2016-17 is to be enclosed, failing which the application will be treated as cancelled.
2. The Institute must have its own hospital and which shall be supported by valid documents i.e. a certificate from the concerned Director, Medical Education or Director, Health Department of the concerned State is to be submitted on the matter failing which the EOI will be treated as cancelled.
3. The Institute must have its own academic building, well equipped facilities having standard laboratories, libraries and spacious classrooms as per norms of INC / other Councils / University. A certificate from the concerned Director, Health Department on the matter is to be furnished failing which the EOI may be treated as cancelled.
4. The Institute must have adequate number of faculties with minimum 5 (five) years of teaching experience. CV of the teaching faculty and college authority is to be submitted. A certificate from the Director, Health Department on the matter is to be enclosed failing which EOI shall be treated as cancelled.
5. The Institute must have its own separate hostel for boys and girls having spacious accommodation with adequate provisions of running water, safe drinking water, electricity, furniture etc. as per the norms prescribed by the Indian nursing Council / University. The Institute shall also provide conveyance from hostel to Institute and back wherever it is needed.

6. The Institute should have good track record of placement and assure 100% placement of the students sponsored by the State Govt. and supporting documents have to be submitted. A certificate from the Director, Health Department in the month is to be furnished failing which EOI shall be treated as cancelled.
7. The Institute should indicate fee structure for each course in each year and also the total course fees fixed by the statutory authority of the concerned State Government / Fee Fixation Committee of the concerned State Government. There shall not be enhancement of any kind of course fees during the course period.
8. The Institute while accepting the EOI shall submit in writing that no back fees of examination, late fee, less percentage of the attendance fees and any other extra fees etc. shall be charged from the students and the department directly or indirectly.
9. Preference will be given to those Institutes whose medium of instruction / teaching is in English only and where students of NE States have been sponsored by the concerned State Government (Supporting documents to be enclosed).
10. Expenditure of medical treatment except major surgical cases like heart, bone, chest, kidney and chronic disease will be borne by the concerned Institute. There should be at least one medical check - up for the students in every month. The Institute shall ensure issuing of health card to each student for providing treatment facilities.
11. The students will be allowed to visit Tripura once in every year during the vacation or after the examination. To and fro journey expenditure (sleeper class / bus, train) for the students will be initially incurred by the Institute and shall be reimbursed by the concerned Department of the State Govt.
12. During the journey from Agartala to the concerned Institute and from the Institute to Agartala, a responsible guide / escort will be provided with students by the concerned Institute whose TA / DA shall be borne by the Institute.
13. The Institute will submit weekly Menu of food (both veg & non-veg) in sufficient quantity preferably Bengali food.
14. After successful completion of the course, the Institute shall be responsible to deliver the Registration / degree / diploma certificate (including all original certificates) to the students within 60 (sixty) days from the date of publication of the result. No extra fees shall be charged from the students or the departments for the certificate. The concerned Institute shall be responsible for correction of any error or printing mistakes in the certificates without charging any extra fees.



15. The MOU shall be signed by the Principal or Authorized Officer of the Institute only duly authorized by the Chairman / Secretary of the Institute.
16. The Institute shall submit earnest money of Rs. 5.00 lakhs only from any Nationalized Bank along with the technical bid in favour of the Director, Scheduled Tribes Welfare Department.
17. Bank Guarantee equivalent to 2.5% of the total course fees i.e. ordered value for the course shall be submitted in favour of the Director of the sponsoring Department after selection of the Institute from any Nationalized Bank and it shall be refunded after successful completion of the course by the students. The guaranteed amount as deposited in the bank shall be forfeited in case any disputes arises between the Institute and the sponsoring Departments and failure to comply with the terms & condition in the MOU.
18. For resolving of any dispute, if arises, the jurisdiction of the Court of Law will be within the state of Tripura only.
19. Interested Institutes may submit EOI with technical and financial bids for each course and the bid may be kept in 2 (two) separate envelope and thereafter, put it in a big envelope with Bold Subscription on the envelope. The EOI should be submitted either in person or by post by 15:00 hrs of 20th June, 2017 addressed to the Director, Directorate of Welfare for Sch. Tribes, Pandit Nehru Complex, Gurkhabasti, Agartala, West Tripura, PIN – 799006.
20. No EOI submitted after 15:00 hrs on **20th June, 2017** shall be accepted. The EOI will be opened **on 21st June, 2017 at 11:00 hrs**, if possible. The State Level Committee, Govt. of Tripura reserves the right to accept or reject or cancel the Expression of Interest without assigning any reasons thereof.
21. Before final selection of the Institutes the official team constituted by the State/Department shall inspect the reference site of the Institute physically to verify the identity and the competency of the Institute and particularly to evaluate the specific criteria and during selection the report of the team will be given priority.
22. The Institutes who tendered EOI shall furnish its preceding last three (3) years past experience certificate in the relevant filed of education/course issued from its affiliated authorities.

23. The decision of the State Level Committee shall be final and binding in the selection of the Institutes.
