
The Tribal Advisory Committee will generally meet once in each quarter of the year. The Chairman, however, may call the meeting as often as he may consider necessary.

Tribal Advisory Committee will discuss measures for the Welfare of Scheduled Tribes and give recommendations for consideration of the Government.

The Agenda of the meeting of the Tribal Advisory Committee will be drawn up on the basis of suggestions from the members and with the approval of the Chairman. The Member-Secretary will circulate Notice of the meeting and any other paper as may be indicated by the Chairman amongst the members. He will arrange to maintain "Records of Discussion of the meeting" and submit the same to the Government for consideration.


