2. Job responsibilities of Citizen Engagement and Social Inclusion Specialist:

- Design, Develop, manage, implantation of Tribal Development projects.
- Leadership & technical support.
- Data analytics
- Field Demonstration
- Resource Pooling for Assignment Effectiveness.
- For over-all coordination, liasoning and facilitation with the line Govt. Dept.
- To be involved in overall development of the project keeping in mind different stakeholders and beneficiaries.
- Collaboration with technical specialists, develop comprehensive yet flexible plan for community engagement and social inclusion for CCA Activity community-level work.
- Develop and utilize communications materials to catalyze, motivate and inform community groups and CSOs to collaborate with the CCA Activity;
- Collaboration with the Private Sector Engagement to identify opportunities for partnerships to test and amplify positive impact of investment options;
- Collaborate with Tribal development Institutions and other technical staff to identify, implement, monitor and report on Grants under Contract to relevant community organizations and NGOs;
- To seek opportunities for synergy and cross learning/training; and
- Provide significant contributions to EAP project deliverable documents including but not limited to Startup and Preliminary Work Plan, Annual Work Plan, Weekly Updates, Quarterly Reports, Annual Reports and Activity Monitoring, Evaluation and Learning Plan.

3. Period of Contract:

The consultant will be engaged on purely temporary and on contractual basis for a period of 01(one) year and may be extended on performance and requirement.

4. Eligibility for Citizen Engagement and Social Inclusion Specialist:

- **Academic Qualification:** A candidate must have a PG Degree/Diploma in Political Science, Anthropology, Sociology, Social Work, Rural Management/ Development discipline.
- **Experience:** Minimum 6 years of relevant experience.
- **Desirable :** Candidate having experience in the North Eastern region and in world Bank aided projects/EAP.

5. Remuneration of the consultant:

- The monthly remuneration of the consultant will be an amount of Rs. 1.00 lakh. The amount of remuneration so fixed remain unchanged from the term of contract.
- There will be no annual increment/percentage increase during the initial contract period of 01 (one) year.
- The income tax or any other tax liable to be deducted as per the prevailing rules will be deducted at source and for this, Department will issue TDS certificate.
- No DA (Dearness Allowance) shall be allowed during the period of contact.
- If the contract extended beyond 1 year than an annual increment of 5% may be applicable in the successive years.

6. Age Criteria:

- A candidate should not be more than 50 years of age on the last day date of application.

7. Code of Conduct:

- The consultants shall follow the rules and regulations of the Department.
- The Consultants shall not reveal to any person or organization, confidential information pertaining to the organization, its work and its policies.

8. Confidentiality of data and documents:

- The data collected/produced as well as deliverable produced for the Tribal Welfare Department, Govt. of Tripura shall remain with this office. No one shall utilize or publish or disclose or part with, to third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment from the Tribal Welfare Department, without the express written consent of this office.
