- V. "CES" means Centre of Excellence for Sports.
- VI. "EMRSST" means Eklavya Model Residential School Selection Test.
- VII. "EMRSLT" means Eklavya Model Residential School Lateral Entry Test.
- VIII. "ST" means Scheduled Tribes.
- IX. "PVTG" means Particularly Vulnerable Tribal Group.
- **X. "DNT**" means Denotified Tribes.
- XI. "NT" means Nomadic Tribes.
- XII. "SNT" means Semi-Nomadic Tribes.
- XIII. "LWE" refers to Left Wing Extremism.
- **XIV. "CWSN"** means Child with special needs and suffering from disability. To be determined as per the provision mentioned in RTE Act 2009 or as defined by the concerned State Govt.
