MEMORANDUM

State Government has approved a broad package for rehabilitation of returnees who had surrendered to various authorities of Central / State Government prior to 1st April, 1998 without signing any accord of surrender. The State Government has constituted a 7-member State Level Committee headed by the Chief Secretary for monitoring of the implementation of various scheme under the broad package.

- 2. It is further decided that the various schemes under the broad package shall be implemented by the line departments. The Tribal Welfare Department has been made the Nodal Department for overall implementation of the package. Accordingly, Tribal Welfare Department will be forwarding applications submitted by the returnees to the respective line departments for sanction of schemes as indicated in the Annexure.
- 3. The fund for implementation of various schemes under the broad package will be met out of the State Budget. Therefore, the respective line departments are required to make necessary provisions of fund in the budget during the finalisation of revised estimate (RE) of the current financial year on the basis of the applications to be sponsored by the Tribal Welfare Department and in terms of the financial limit of scheme opted for.
