

REVISED SCHEME FOR GIVING ADDITIVE POST-MATRIC
SCHOLARSHIPS TO SCHEDULED TRIBE STUDENTS.

1. Object of the Scheme :

The scheme for giving additive to Government of India's Post-Matric Scholarship has been in operation from the year 1985-86. In view of price escalation, it has been observed that enhancement of the rate of additive to post-Matric Scholarship is necessary. Moreover, the rate of Boarding House Stipend to S.T. students reading upto Class X is much higher than the rate of Government of India's Post-Matric Scholarships. It is therefore felt necessary to raise Post-Matric Scholarship to S.T. students reading in Post-Matric stage at least to the amount equivalent to Boarding House Stipend.

2. Rate and coverage :

Till the end of 1987-88, the rate of additive to Govt. of India's Post-Matric Scholarship was Rs. 75/- per month per Boy hosteller and Rs. 65/- per month per Girls hosteller. Following enhancement of Boarding House Stipend from Rs. 5/- per day to Rs. 5/- per day from the year 1988-89, the additive to post-matric Scholarship has also been increased to Rs. 165/- per month per boy's hosteller and Rs. 155/- per month per Girl's hosteller.

Till the year 1988-89, the scheme covered only S.T. students reading in Classes XI & XII. From the year 1989-90, the Govt. has decided that the scheme will cover all S.T. students reading in Post-Matric stage. The rates of Additive to Govt. of India's Post-Matric Scholarship will be as follows :-

3. Eligibility :

The scheme will be applicable only to those S.T. students receiving Scholarships under Centrally Sponsored Post-Matric Scholarship scheme as hostellers. S.T. students considered as eligible to receive scholarship under Centrally Sponsored Post-Matric Scholarship scheme will automatically be treated as eligible to receive additive Post-Matric Scholarship under this Scheme. In the event that an S.T. student is getting help of the amount of post Matric scholarship as per Centrally Sponsored Post-Matric Scholarship scheme, the amount of additive Post-Matric Scholarship should also be reduced to half of the amount indicated in the Scheme.

If there be any S.T. student pursuing Post-Matric studies in technical course not mentioned in the scheme but receiving scholarship under Centrally Sponsored Post-Matric Scholarship Scheme, he will also be entitled to receive additive under this scheme to the extent the rate of Post-Matric Scholarship falls short of Rs. 240/- per month.

4. Implementing agency :

Director of Higher Education and Director of School Education, Government of Tripura will be the implementing Officers. Application form will also be prescribed by them as they think fit.
