## **NOTIFICATION**

## Subject: Procedure for Recognition of New NGO Hostels and Enhancement of Seat Capacity for the grant of Boarding House Stipend under the "Tripura Grant of Scheduled Tribes Boarding House (Managed by Non-Government Organisation) Stipend Rules 1999."

It has been observed that proposals for the recognition of new hostels and the enhancement of seat capacity in existing approved hostels are being submitted directly to the Directorate of Tribal Welfare or higher offices. This notification outlines the procedure to streamline the application process for the grant of Boarding House Stipend under the "Tripura Grant of Scheduled Tribes Boarding House (Managed by Non-Government Organisation) Stipend Rules 1999."

2. In this regard, it is hereby clarified that interested societies must fulfil the following criteria to ensure the availability of basic infrastructure and amenities in the hostels :

i. For recognition of a new NGO Hostel (Inspection format enclosed at Annexure-A):

- a. Basic information about the hostel
- b. Registration details of the hostel under the Society Act
- c. Details of boarders
- d. Availability of basic amenities
- e. Building status
- f. Land/property ownership details
- g. Academic performance of boarders
- ii. For enhancement of intake capacity of a recognized NGO Hostel (Inspection format enclosed at Annexure-B):
  - a. Basic information about the hostel
  - b. Number of boarders (approved and proposed)
  - c. Availability of basic amenities
  - d. Academic performance of boarders

3. Upon fulfilling the above criteria, the NGO Hostel authority shall submit their proposal to the office of the concerned Sub-Divisional Welfare Officer (SDWO) for consideration of the Boarding House Stipend under the "Tripura Grant of Scheduled Tribes Boarding House (Managed by Non-Government Organisation) Stipend Rules, 1999." The proposal must be submitted in the month of April each year.

4. The office of the SDWO shall conduct a physical verification of the proposal submitted by the NGO Hostel authority, including verification of physical infrastructure for accommodating the proposed number of boarders. Upon fulfilling the criteria, the verification report shall be placed before the Sub-Divisional Level Boarding House Committee (SDLBHC), and its recommendation shall be documented in the form of meeting minutes or a resolution. The list of recommended hostels shall be

forwarded to the Directorate of Tribal Welfare. Hostels that are not recommended or do not fulfil the criteria shall be informed in writing about the deficiencies in documents or amenities.

5. This entire process of verification and recommendation shall be completed and compiled at the Sub-Divisional level by the month of May each year.

6. A communication will be made to the Sub-Divisions in the month of June to submit the proposal copies, inspection reports, SDLBHC recommendations, and forwarding letters along with the list of recommended hostels to the Directorate of Tribal Welfare, Government of Tripura, through a Google form or any other designated Government web portal. If necessary, the Directorate may further cross-verify the recommended hostels.

7. Based on the availability of funds, and after approval of intake capacities of Government hostels, the Directorate of Tribal Welfare, Government of Tripura, will process the file for approval of the recommended proposals by the higher authorities under the "Tripura Grant of Scheduled Tribes Boarding House (Managed by Non-Government Organisation) Stipend Rules, 1999."

8. Any proposal submitted directly to the Directorate or forwarded by the offices of DWO/SDWO without the recommendation of the SDLBHC shall not be entertained.
