MEMORANDUM

Whereas, a total of 35,665 Scheduled Tribe (ST) students' scholarship applications have been successfully verified and approved through the National Scholarship Portal (NSP) under the "Umbrella Scheme for Education of ST Children - Post Matric Scholarship (PMS) for ST Students-Tripura" for the academic year 2023-24.

Whereas, scholarships for 21,272 ST students have been disbursed through the Public Financial Management System (PFMS) directly into the students' Aadhaar-seeded bank accounts, utilizing the available funds of the Directorate of Tribal Welfare, Government of Tripura.

Whereas, additional funds were requested from the Ministry of Tribal Affairs, Government of India, to cover the remaining 14,393 approved students. Subsequently, the Ministry has sanctioned the necessary funds to the Finance Department, Government of Tripura.

Whereas, the Department remains committed to disbursing the scholarship amounts to all genuine and error-free approved applications through PFMS, ensuring transfer to the Aadhaar-seeded bank accounts of the students, following all required official procedures.

Now therefore, in the interest of the students, all Heads of Institutions (both within and outside the State of Tripura) are kindly requested not to impose any extra or late fees on students who have taken admission with the expectation of paying academic fees from the scholarship fund. Students should also be permitted to appear for their examinations (if any) to prevent any disruption in their academic progress.

Heads of Institutions are further requested to ensure that no eligible ST student from Tripura is denied the opportunity to sit for examinations due to delays in the disbursement of scholarship payments.
