Subject: Clarification regarding **"Hosteller"** in connection with Post-Matric Scholarship (CSS) to ST students of Tripura.

This is for information all concerned (Institute/ Students) in connection with Post-Matric Scholarship to ST students of Tripura that as per revised guideline of ST Post-Matric Scholarship (https://twd.tripura.gov.in/sites/default/files/Revised_Guidelines.pdf.), normally the term 'Hostel' is applicable to a common residential building and a common mess for the students run under the supervision of the educational institution authorities. In case the educational institution authorities are unable to provide accommodation in the school/college Hostel, an approved place of residence can also be treated as Hostel for the purpose of this scheme. The place shall be approved by the Head of the Institution (the concerned Institutions are advised to follow the revised guideline of Post-Matric Scholarship Para 3.4.2, Note No.3, Page **No.8**). In such case, a certificate/ declaration (enclosed) to the effect that the student is residing in an approved place of residence as he/she is unable to get accommodation in the school/college hostel should be furnished by the concerned Head of the Institution.

It needs to be clarified that such **deemed hostels** should consist of such accommodation as is hired **at least** by a group of **5 (five)** students living together, usually with common mess arrangements. **It is further clarified that the stipend/ scholarship is a sort of incentive provided to a student for pursuing a particular course and in no way meant to provide for reimbursement of boarding and lodging charges like mess, hostel or other similar charges**.

This Notification should be brought to the notice of the ST students by all the respective Head of the Institutions/ Principals. The Declaration/ Certificate (enclosed) has to be kept in safe custody by the concerned Head of the Institutions for future reference.
