NOTIFICATION

As per direction of the NIC, HQ, Ministry of Electronics & Information Technology (MEITY), Govt. of India, this is to inform all the concerned ST students domicile in Tripura and the concerned HoI/ INO of different Institutions (Govt./Private) that from the **academic/ financial year 2024-25 One Time Registration (OTR) is mandatory for applying any scholarship scheme through National Scholarship Portal (NSP).**

One-Time Registration (OTR) is a unique number provided to streamline the registration process. Students can register with their mobile number through National Scholarship Portal (<https://scholarships.gov.in/>) and complete **e-KYC (electronic Know Your Customer)** with **face-authentication** through NSPOTR App. Once this process is completed, an OTR number will be generated and sent to the students/ user's registered mobile number. **The OTR number is generated once and remains valid throughout the student's academic career.**

The concerned students are advised to complete the face-authentication using option **“eKYC with Face-Auth”** on NSPOTR App before applying for Scholarship in NSP.
