**4. Financial support to be provided under the scheme to selected ST students:**

- The course fee shall be provided to the Empanelled Coaching Institution through CTOS or any other e-Payment system.

- b. Every Empanelled Institution will have to comply with necessary condition for payment methodology selected.
- c. The Institution shall issue payment receipt in soft/hard copy to the paying beneficiaries and also send copies to the Directorate of Tribal Welfare (DTW).
- d. The payment of course/coaching fee shall be in 2 (two) phases i.e 50% of course/coaching fee in each phase. One after 30 days of enrollment of the student in the institutions and the other in the ending month of the course.

**5. The Eligibility Criteria for the ST students are as given below:-**

- a) Must be domicile of Tripura.
- b) Must belong to ST Community.
- c) Must be at least X (Madhyamik) or equivalent passed for JRBT and other Gr-C/Gr-D recruitment Exam.
- d) Graduation with 50% marks for combined course for SSC/Railway/IBPS/TPSC combined Examination.
- e) Graduation with 50% marks and B.Ed/D.El.Ed for Combined Course for CTET, STPGT, STGT, TET-II, TET-I and other teaching related recruitment Examination.
- f) Shall not be regular student in any Institution.
- g) Shall not be regular employee in any Govt. /Private Organization.
- h) Family annual income from all sources must be below Rs.2.5 lakhs.

**6. Procedure for selection of beneficiaries:-**


- a) Interested students shall submit their online application through the link provided in the Departmental website(<https://twcet.tripura.gov.in>).
- b) Based on the marks obtained in the Madhyamik (X), the Merit list shall be prepared by the Directorate of Tribal Welfare (DTW).
- c) On the day of Counseling Program, candidates will be given opportunity (merit wise) to choose the course and the Institution of their choice among the Empanelled Institution and course offered.
- d) Based on the choice of the candidates and availability of seats the beneficiaries shall be instantly admitted to the Coaching Centre.

**7. Counseling Programme:**

The candidates shall be invited merit wise to choose their course and Institution of their choice and availability of seats.

**8. Terms and condition:**

- a. Any decision taken by the Tribal Welfare Department, Govt. of Tripura shall be treated as final.
- b. The Department reserves the rights to reject any application which are incorrect/incomplete application or submitted after expiry of the application date.
- c. If any document is/are found to be false or fake, the benefit shall be terminated and the institutions shall return the sanctioned amount against such students.
- d. The Tribal Welfare Department will have the power to amend or withdraw the notification without any reason and total seats allocated may increase or decrease as per the decision of the authority.
