Japan Specified Skilled Worker (SSW) Program

With the growing importance of skill development for global employability and sustainable livelihoods, Tripura has witnessed a considerable number of ST students successfully completing ANM, GNM, and B.Sc Nursing courses. Recognizing this potential, the Directorate of Tribal Welfare in collaboration with the Directorate of Skill Development, has undertaken a joint initiative to empower the tribal youth through quality skill training in nursing, Japanese language training, capacity building, and international employment opportunities in Japan under the Specified Skilled Worker (SSW) Program. This initiative will not only help bridge the skill gap in the healthcare sector in Japan but also contribute significantly to the career growth and livelihood of the selected individuals. The programme will be funded under Chief Minister's Tribal Development Mission

The following **terms and conditions** are hereby notified for the candidates under the Japan SSW Program:

1. Eligibility Criteria

Applicants must fulfill the following conditions:

- a. Must be a domicile of Tripura.
- b. Must belong to the Scheduled Tribe (ST) community.
- c. Age should be between 20 to 27 years as on the date of application.
- d. Educational qualification: Must have successfully completed ANM/GNM/B.Sc Nursing.
- e. Must have secured minimum 60% marks in the final examination of ANM/GNM/B.Sc Nursing.
- f. Annual family income should not exceed ₹5,00,000/- (Rupees five lakhs only).
- g. Candidate must have valid registration with the State Nurses' Register of the Tripura Nursing Council.
- h. Marital status: Unmarried.
- i. Must be fluent in English or Hindi.
- j. Scanned copy of Certificates to be uploaded in support of Point no. 1.(a) to 1.(g) during application submission.

2. Mode of Application

- a. Applications are invited through open advertisement through this Google Form link [<https://docs.google.com/forms/d/e/1FAIpQLSclCQ8zZ4s5inKBiI0Z0hdA1Ivh6NObyero7FMoLMxVas66ag/viewform>].
- b. Applications are to be submitted only in online mode within 10th Oct, 2025.
- c. Applications received after the due date or found incomplete shall be rejected.
- d. Both sides of the final marksheet of one's last educational qualification are to be uploaded.

3. Selection Process

- a. All the applications shall be thoroughly scrutinized by following the eligibility criteria.
- b. The Directorate of Skill Development shall conduct the selection process, which will consist of either:
 - a Written Test followed by Viva Voce, or
 - Viva Voce only, depending on the number of applications received.
- c. The final list of selected candidates, along with a waiting list, shall be prepared once the entire selection process is conducted.
- d. Once selected, they will be sponsored by the Tribal Welfare Dept, Govt. of Tripura for a 9 month residential training that would cover their training expenses, fooding, lodging, VISA expenses, medical fees, etc.
- e. 20 candidates will be selected for the course (the no. of selected students may increase or decrease depending on the number of applications received and fund availability).

4. Training Obligations

- a. Selected candidates will undergo a nine-month residential training program at NSDC International Academy, Greater Noida, NCR.
- b. An undertaking is to be signed by the candidate and their guardian to complete the nine-month residential training course in NSDC International Academy, Greater Noida, NCR, wherein in case they don't complete the course or leave the course duration in between, then the entire sponsored fee is to be refunded by the candidate.
- c. In case a candidate is unable to clear the qualifying examination after completion of the course, the cost of all subsequent examinations shall be borne by the candidate.

5. Monitoring & Inspection

- a. A joint inspection shall be conducted by the Directorate of Skill Development and the Directorate of Tribal Welfare at NSDC International Academy training institute prior

to sponsoring the candidates and also during the training period for verification purposes.

6. General Conditions

- a. The decision of the Tribal Welfare Department in all matters relating to eligibility, selection, training, and sponsorship shall be final and binding.
- b. The Tribal Welfare Department reserves the right to modify, cancel, or withdraw this notification at any stage without assigning any reason.
- c. The department shall sponsor the selected candidates for the training program at the rate of ₹2.86 lakhs/per candidates that will cover their training expenses, fooding, lodging, exam fees, VISA fees, medical fees, and etc.
