NOTICE TO SHOW CAUSE

Subject: Fraudulent Claiming of ST Post-Matric Scholarship claims through the NSP for the AY/FY 2023-24: Initiation of Legal Action.

Whereas, it has been revealed from the enquiries conducted by competent administrative authorities that 34 (thirty-four) students, as enlisted vide Annexure-I hereto, had applied for ST Post-Matric Scholarship for the AY/FY 2023-24 through the National Scholarship Portal (NSP), uploading fake income certificates;

And whereas, the production of such fake income certificates to usurp scholarship grants constitutes misappropriation of public money, document forgery, and defrauding the scholarship sanctioning authority, and therefore, amounts to a criminal offence;

Now therefore, the aforesaid 34 students are hereby asked to show cause as to why F.I.R.s shall not be lodged against them for having submitted fake income certificates through the NSP with the motive of falsely establishing their claims for ST Post-Matric Scholarship for the AY/FY 2023-24.

Their reply, if any in defence, shall reach the undersigned in writing no later than the **16th April**, **2025**, failing which actions shall ensue against them *ex parte*.
