# TRIPURA PUBLIC SERVICE COMMISSION

Advt. No. 03/2021

Online applications are invited from bonafide citizens of India for selection of candidates for the under mentioned posts.

164 (One-hundred and sixty-four) (UR-35 SC-28 & ST-101) permanent posts of Junior Medical Officer/ General Duty Medical Officer, Grade-IV of THS, Group-A Gazetted under the Health and Family welfare Department, Government of Tripura in the Scale of Pay of Rs. 54,000/-in the pay Matrix level-14, of T.S.C.S. (Revised Pay)Rules, 2018(Pre-revised Pay Band-4 Rs.15,600-39,100/- with Grade Pay of Rs.5,400/-)

#### **EDUCATIONAL QUALIFICATION & EXPERIENCE :-**

- (iii) A Medical qualification included in the First or Second schedule or Part-II of the Third schedule (other than Licentiate qualification) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in part-II of the Third Schedule should fulfill the conditions stipulated in section 13(3) of the Indian Medical Council Act, 1956.
- (iv) Completion of internship and permanent Registration Certificate of any State Medical Council/Medical Council of India.

Age: Up to 40 years as on 17-05-2021. Upper Age-limit is relaxable by 5(five) years in case of SC, ST, Differently abled (PH) candidates and Government Servants, provided that the Govt. Servants of SC/ST/Differently abled (PH) category shall not get this relaxation over and above the general relaxation of 5 (five) years available to them.

The last date of receiving online application is <u>17-05-2021 (4.00 PM</u>). The application(s) received after the closing date will not be entertained.

List of provisionally eligible candidates will be available on and from **20-05-2021**.

Interview for recruitment to the post may be started from **25-05-2021**.

#### **Selection Process:**

- (a) As per service rule the Recruitment process will comprise of 02(two) steps viz.-i)Short listing of candidates on the basis of API calculation (Academic Performance Index)( 100 marks) & 10 marks for the candidates who have performed duty of Covid-19 positive patients in the different health institutions of the Govt. of Tripura, ii) Interview process (05 marks).
- **(b)** On the basis of total API scoring, including 10 marks for duty of Covid-19 positive patient, a limited no. of candidates, maximum 3 **(three)** times of total vacant posts (in category wise), will be selected merit wise for interview.
- (c) It is also mentioned here that candidate(s) scoring marks equal to that of the last qualified candidate in the API scoring shall also be called for interview.
- (d) The final selection will be made in order of merit on the basis of the marks obtained by a candidate in the API calculation (out of 110) and by adding the marks obtained in the Interview/Personality Test.(Out of 05)

(e) In the list of recommendation, merit position of candidates securing equal marks will be finalized as per their seniority of age. The same procedure is to be followed for preparing waiting List, if there be any.

Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed in Recruitment Rules/ Service Rules.

### Important information:

### 1. Online Application Portal:

- (a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the necessary instruction's regarding filling up of online application.
- (b) Online Application Portal will be available on Commission's website from 10-05-2021 to 17-05-2021(4.00 PM). Before applying for the post, an applicant shall register his/her bio- data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. <a href="www.tpsc.tripura.gov.in">www.tpsc.tripura.gov.in</a> once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through Commission's website.
- (c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respects.
- (d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receive Number shall not be adjusted against any other Receipt Number.
- 2. (a) Candidates are required to submit self attested copy of certificates in support of their claims regarding Qualification from Madhyamik onwards, Experience, Permanent Residence Certificate/Citizenship, Age proof Certificates, MBBS all mark sheets, Registration Certificate issued by appropriate authority, Experience Certificate (issued by appropriate authority) including duty of Covid-19 positive patient (after completion of Internship) with clear mention of starting date and end date, API calculation sheet as per TPSC format along with printed copy of Online Application in the receipt section of TPSC, Agartala, West Tripura within 18-05-2021 (4.00 PM), failing which candidature will be summarily rejected. The Commission will not entertain any application thereafter.

Candidates are not required to upload any certificate in support of their claims during submission Online applications.

(b) Applicants must be in possession of the prescribed minimum qualification(s) for the post on the closing date for submission of application as mentioned in the advertisement. Their admission at all the stages of recruitment process will be purely provisional, subject to their satisfying the prescribed eligibility conditions. Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission.

## (3) Rate of Recruitment Fees:

- (a) Group-A Posts: Rs.300/- (Rupees three hundred) only for General Candidates and Rs.250/-(Rupees hundred and fifty) only for ST/SC/ BPL card holders/Physically Handicapped Candidates.
- **(b) SC/ST Candidates of other States** (not recognized by the Govt. of Tripura) should apply for unreserved vacancy as general candidate along with recruitment fee prescribed for general candidates.
- (c) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.
- **(4)** Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.
- (5) Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.
