1. Scope/ Item of Work:

3. Eligibility Criteria:-

- iv. In addition to point (iv), the agency or firm must have at least 25 nos. work experience in Designing& Development, Hosting and Maintenance of Application Web portal mainly related to educational activities (even with private organization).

4. The terms and conditions of the EOI are as follows:-

- The Design & Development of the Website/Web portal should be completed within a period of 15 days from the date of placing the work order.
- The penalty clause will be effective, if the work is not completed within stipulated time period. A penalty at the rate (per day) of 1.00% of the total project cost of the will be levied if

it is delayed by more than the stipulated time. The penalty will be doubled, if it is delayed by 30 days or more. For delays beyond 30 days from the stipulated time, tender may also be liable to be cancelled.

- The eligibility criteria shall be considered as Technical Bid.
- In addition to technical bid participating shall also submit quotation for the same project, which shall be considered as Financial Bid.
- Only on satisfaction of the technical bid (eligibility), the Financial Bid of the participating agencies will be compared.
- The Lowest bidder in the Financial Bid shall be awarded the contract.
- On Final approval by the competent authority of the EoI inviting agency (Tribal Welfare Department, Govt. of Tripura), a MoU (Memorandum of Understanding)shall be signed between the EoI inviting agency and the selected bidder.

5. Award of Contract and notification and signing of Agreement:

6. Tender Fee:
