

- Incomplete and conditional Quotation will not be entertained.



5. Tender Fee (TF) & Earnest Money Deposit (EMD):

- a) The participating bidder has to pay a non-refundable amount of Rs. 3000/- (Rupees Three Thousand) only as **Tender Fee (TF)** and a refundable amount of Rs. 32,000/- (Rupees Thirty Two Thousand only) as **Earnest Money** by Demand draft (DD)/ banker's Cheque obtained from any nationalized scheduled bank having branch at Agartala, payable to the **DDO, Directorate of Tribal Welfare, P.N Complex, Gurkhabasti, Agartala-799006.**
- b) The EMD shall be refunded to all the bidders including the lowest bidder in their respective bank account after award of contract.
- c) No interest shall be payable against the EMD deposited by a bidder.
- d) There shall be **NO EXEMPTION** from submitting EMD.
- e) The Successful bidder has to submit the Performance Guarantee @ 3% of Bid Value. No interest will be paid to the bidder on Performance Guarantee. The Performance Guarantee will be returned after execution of task.
