4. General Term & Conditions:

- a) Supply order may be given for single or bulk of item at once and supplier will have to supply and deliver the item within **15(fifteen) days** to Hostel location as mentioned above.
- b) Rates should be mentioned both in Figure and words in Rupees inclusive of tax, fixed transportation charge etc.
- c) Incomplete and conditional Quotation will not be entertained.

5. Earnest Money Deposit (EMD):

- a) Earnest money deposit **Rs.4000**/- (refundable) by Demand draft (DD)/ banker's Cheque obtained from any nationalized scheduled bank having branch at Agartala, payable to the **DDO**, **Directorate of Tribal Welfare**, **P.N Complex**, **Gurkhabasti**, **Agartala-799006**.
