The Special Coaching in Core Subjects *i.e.* English, Mathematics and Science subjects shall be imparted to the ST students at Bru Settlement Sites in the State of Tripura as per list enclosed at **Annexure-I** under the Scheme of "Special Coaching in Core Subjects to ST students" for the year 2025-26.

The concerned **Sub-Divisional Magistrate (Member Secretary of Sub-Division Level Boarding House Committee (SDLBHC)** is hereby instructed to take necessary action for implementation of Special Coaching in Core Subjects *i.e.* English, Mathematics and Science at Bru-Settlement Sites per following conditions:-

- a. Coaching Classes shall be for maximum period of 10 (ten) months *w.e.f.* **24**th **April, 2025 to February, 2026.**
- b. Teachers shall be engaged with an honorarium of Rs.7,000/- (Rupees seven thousand) only per month per teacher for the maximum period of 10 (ten) months.
- c. Teachers who were already engaged in the last FY (2024-25) for the same shall continue for this FY 2025-26.
- d. If a teacher at any of the coaching centers is found to be uninterested in taking classes or has left for any reason, they should be replaced immediately with a new teacher.
- e. If any center is non-functioning, it should be reported immediately to the Directorate of Tribal Welfare, Govt. of Tripura.
