
**EXPRESSION OF INTEREST**

Expression of Interest (EOI) is hereby invited from the reputed and NCTE recognized B.Ed Institutions located (inside & outside Tripura) for imparting quality education in B.Ed (2 year) course to ST students. The students shall be sponsored by the Tribal Welfare Department, Govt. of Tripura during the year 2018-19 (for B.Ed Course) - tentative 50 seats.


**The terms and conditions of the EOI are as follows:-**

1. The Institute must have the approval of National Council for Teacher Education (NCTE) from the concerned University, whichever is applicable and up to date registration certificate of NCTE is to be enclosed, failing which the application will be treated as cancelled.
2. The Institute must have its Academic building and which shall be supported by valid documents i.e. a certificate from the concerned Director, Education Department of the concerned State is to be submitted on the matter failing which the EOI will be treated as cancelled.
3. The Institute must have its own academic building, well equipped facilities having, libraries, playground and spacious classrooms as per norms of NCTE / other Councils / University. A certificate from the concerned Director, Education Department on the matter is to be furnished failing which the EOI may be treated as cancelled.
4. The Institute must have adequate number of faculties with CV of the teaching faculty and college authority is to be submitted.
5. The Institute must have its own separate hostel for boys and girls within the campus premises having spacious accommodation with adequate provisions of running water, safe drinking water, electricity, furniture. as per the norms prescribed by the NCTE.

6. The Institute should indicate detail fee structure for each year .The institution should submitted financial & technical bids separately .
7. The Institute while accepting the EOI shall submit in writing that no back fees of examination, late fee, less percentage of the attendance fees and any other extra fees etc. shall be charged from the students and the department directly or indirectly.
8. EOI submitted after 15:00 hrs from **23<sup>th</sup> June, 2018** to **28<sup>th</sup> June, 2018 upto 3.00 P.M.** shall be accepted. The EOI will be opened **on 28 June, 2018 at 4:00 P.M.**, if possible. The State Level Committee, Govt. of Tripura reserves the right to accept or reject or cancel the Expression of Interest without assigning any reasons thereof.
9. The Institutes who tendered EOI shall deposit 2.5% of the total project cost by DD at National Bank.
10. The decision shall be final by the Tribal Welfare Department for selection of the Institutes.
